# The case for a community pub and shop in Stoke St Gregory

At present we have two pubs and a shop in Stoke, but the owners have been trying to sell for years. In the current economic climate this is becoming increasingly difficult, and the situation cannot continue indefinitely. A village with no pub or shop would be a much diminished place, and we fear that the loss of these services would mark an irreversible decline in the fortunes of Stoke St Gregory.

## The proposal

If the existing businesses do not sell, one option would be for the Parish Council to buy the Royal Oak, to refurbish it to include a village shop and a café staffed by volunteers, and to run it for the community. A number of other facilities could potentially be included over time. The opportunity to do this is unlikely to come again.

Another option would be to set up an independent community shop. In order to plan for either outcome, we need to have a clear idea of the demand in the village, and of people's willingness to volunteer.

## The challenge

A community shop/pub can only become a reality if a majority of the village wants it and can offer support on many levels: we need a number of individuals who are prepared to put time and effort into setting up the enterprise and managing the finance etc. Secondly, although the majority of the startup money might have to come from long-term public works loans and grants, in order to secure these we would need some financial support from the community in the form of shares.

Next we would need a large number of volunteers (50+), offering a few hours here

and there to share the staffing of the shop. The pub could be staffed by volunteers but more likely by a tenant landlord. Finally we would need customers: enough people have to come in and buy stuff to make it work.

## The benefits

It is a major challenge to establish a community business, but once it is under way it tends to remain successful. Of the many community shops that the Plunkett Foundation has helped to set up over the last 25 years, 96% are still trading. Co-operative pubs are a more recent trend, but 100% are still trading since the first opened in 2004.

The experience for volunteers is also very positive. People can work as much or as little as they like, and many who might otherwise feel isolated can find themselves having an important role in the village, and a say in how the shop is run.

If the attempt to buy the Royal Oak is successful, we ensure the survival of the pub and a home for the continuation of the shop, and we have a permanent focus in the centre of the village, adaptable to whatever the future may throw at us.

## The survey
